**TIME SENSITIVE MATTER**

Dear Sue:

In connection with Georgia Mountain Community Wind, LLC's ("GMCW") Decommissioning Fund as required by Condition 12 of the CPG issued in the above-referenced docket, on or around January 22, 2012 Merchants Bank filed with the Board a Letter of Credit (the original) in the amount of \$50,000. GMCW filed a record-keeping copy of the Letter of Credit with the Board by letter dated March 20, 2012.


GMCW is now preparing to obtain a new Letter of Credit from Merchant's Bank in the amount of \$600,000, as required by the Board's Order dated December 22, 2012. As the Board is aware, as the Beneficiary of the Letter of Credit it is in possession of the original.<sup>1</sup> In order for a new Letter of Credit to be issued, the existing original \$50,000 Letter of Credit will need to be returned to GMCW. Otherwise, the Board would be in possession of two Letters of Credit, both of which could be remitted for payment.

Merchants Bank is intending to issue the \$600,000 Letter of Credit concurrent with the financing for the Project which is scheduled for May 9, 2012. **GMCW thus respectfully requests that the Board provide it with the original \$50,000 Letter of Credit no later than May 4<sup>th</sup>.** We can arrange to have it picked up at the Board's offices at your direction.

<sup>1</sup> Under the terms of a Letter of Credit, the original executed document must be presented and surrendered to the Bank in order to access the funds.


