
Dear Ms. Hudson:

The above-referenced matter was issued a Certificate of Public Good on June 11, 2010. In their Order, the Board stated that no construction for the project should begin until certain plans and proposals were filed by the Petitioner and approved by the Board. As of this date, no plans or proposals have been submitted by Petitioner.


We write this letter with concern that arises from the recent activities in the last two weeks of Petitioner in this case. Petitioner has graded, resurfaced and widened Ted Road. (See photos enclosed.) We were given no warning or notice of the construction being done on Ted Road. The testimony of Petitioner at the technical hearing indicated that there would be no widening of Ted Road. However, the road has been widened from the original 17 feet to 26 feet in some places. The widening of the road also resulted in flowers and plants located at the front of our property being removed and buried. Pre-existing culverts on Ted Road have been buried and/or clogged due to the construction activities of Petitioner. In addition to the road construction, a significant amount of logging has been occurring on Petitioner's property.

We ask the Board to order Petitioner to cease any further construction or site preparation until such time as the plans and proposals ordered by the Board have been submitted and approved.




